

MEMORANDUM OF UNDERSTANDING

This Agreement made and entered into on this May 1st day of 2019 between KARTAVYA. The Career Assister (hereinafter called K-TCA) situated at S.N. Ganguly Road , Ranchi -834001 and Jharkhand College(hereinafter called "JCD" which expression shall include its successors and permitted assigns) with its registered office at Dumri , Giridih-825106.

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

- a. To promote interaction between K-TCA and COLLEGE is mutually beneficial areas.
- b. To provide a formal basis for initiating interaction between K-TCA and COLLEGE.

2. PROPOSED MODES OF COLLABORATION

K-TCA and COLLEGE propose to collaborate through.

- a) Providing student "PROFESSIONAL RECRUITMENT TRAINING" program in 5th & 6th semester and assisting college in placement activities like Campus Recruitment Drive at COLLEGE Campus. Event Organizing and Managing (In respective to placement only) and placement lessening as well.
- b) The eligibility criteria for student selection in campus recruitment will be as per norms of COMPANIES.
- c) Handling placement data of COLLEGE and providing as per COLLEE need.
- d) Training of COLLEGE students through continuing Education programs conducted by K-TCA in Professional Recruitment Training to COLLEGE.
- e) Any other appropriate mode of interaction agreed upon between K_TCA and COLLEGE.

Each of the above modes of interaction will be initiated by entering into a separate agreement between the two parties.

1. CONFIDENTIALITY

- a. During and for a period of three years from the date of disclosure ,each party agrees to consider as confidential all information disclosed by other party in written or tangible and identified as confidential by the disclosing party.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information:
 - Is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
 - Is already known or become known to the receiving party
 - Is received from a third party having no obligations of confidentiality to the disclosing party.
 - Is independently developed by the receiving party; or
 - Is required to be disclosed by law or court order.

2. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind.

3. TERMS AND TERMINATION

This MOU , unless extended by mutual written agreement of the parties , shall expire 3 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at the time. Either party shall have the right to unilaterally terminate this MOU upon 60days prior written notice to the other party . However , no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations shall survive any such termination.

4. RELATIONSHIP

Nothing in this MOU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose.

5. ASSIGNMENT

It is understood by the parties herein this MOU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this Agreement , or rights or obligations arising hereunder, either wholly or in part, to any third party.

6. COSTS OF THE MOU


Both parties shall not be bearer any type of respective costs of carrying out the obligations under this MOU.


